*** To benefit from a fee discount:**

The ISEE bracket within which the applicant has been placed on basis of their economic status and certified by the Authorised Tax Assistance Centres (C.A.F.) must be indicated exclusively via the ISIDATA portal. Foreign students are exclusively required to submit the RECOGNISED ISEE issued in agreement with the ESIDU and valid for three years.

RECOMMENDATIONS:

- 1) The ISEE is only valid during the calendar year, not for subsequent years;
- 2) Contact the C.A.F. well in advance (at least 2 months before) to avoid bottlenecks and delays and to request any necessary corrections;
- 3) Ensure that you submit the C.A.F. document with the registration number and the ISEE indicator via the "personal info" and "student file" portals on the Isidata website;
- 4) NEVER wait until the last day to carry out this and all other paperwork.
